



MEMORANDUM OF UNDERSTANDING

between

THE UNIVERSITY OF DANANG - UNIVERSITY OF SCIENCE AND EDUCATION (VIETNAM)

and

RUSSIAN TIMIRYAZEV STATE AGRARIAN UNIVERSITY (RUSSIA)

The University of Danang – University of Science and Education (Vietnam) and Russian Timiryazev State Agrarian University (Russia) hereinafter referred to as "the Universities", have agreed to establish the following Memorandum of Understanding to promote mutual understanding, academic progress, cultural exchange and the collaboration between both Universities

I

This agreement aims at establishing cooperative relations in the fields of education, research, and other academic exchange programs between both Universities, including cooperation in the areas of activity of the RWCC "Agrotechnologies for the Future".

II

Both Universities will do their utmost to respect the integrity and independence of each other's institution and to treat each other on equal terms to ensure mutual benefits.

III

In order to achieve the purposes mentioned in the preceding two articles, both Universities will strive to realize the following, based on the principles of equality and within the boundary of the legal systems of their respective government.

- 1. Promote academic and educational exchanges.
- 2. Exchange lecturers, administrative staff, and students.
- 3. Support reciprocal visits by professors and researchers.
- 4. Promote collaboration of research activities of academic staff and students.
- 5. Implement joint undergraduate, graduate, and internship programs.
- 6. Cooperate on research projects.
- 7. Cooperate to organize symposiums, workshops and conferences.
- 8. Exchange publications and educational/research materials.

IV

This general Memorandum of Understanding shall be identified as the parent document of any program agreement executed between the Universities. Further agreements concerning any program shall provide details regarding the specific commitments made by each University and shall not become effective until they have been committed to writing and executed by the duly authorized representatives of the Universities.

V

The details for implementation of cooperative activities named above will be agreed upon by negotiation between both Universities.

VI

This Memorandum of Understanding will come into effect from the date on which it is formally signed by both Universities and will be effective for a period of 5 (five) years. This Memorandum of Understanding can be amended or nullified by the agreement of both Universities. At the end of each 5-year period, this Memorandum of Understanding will be renewed for successive 5-year period, unless a 6-month advanced written notice of cancellation by either University is proposed in order to nullify this agreement.

VII

This Memorandum of Understanding is signed in two identical copies of which each University receives one copy.
